Dear Ms. Guzman:

On behalf of Governor Sisolak, as his appointed designee, this letter informs you of our electronic transmittal of the Nevada Regional Haze State Implementation Plan for the Second Planning Period (Regional Haze SIP) to USEPA through the State Planning Electronic Collaboration System (SPeCS) for SIPs. The SIP revision is also available for download at https://ndep.nv.gov/air/planning-and-modeling/regional-haze-and-bart. The SIP is submitted to address certain requirements of 40 CFR part 51 section 308, "Regional haze program requirements" and CAA section 110(a)(2)(D)(i)(II), for interstate visibility transport. NDEP requests approval of the Regional Haze SIP into the Nevada State implementation plan.

In addition, the NDEP is withdrawing certain elements of the 2012 PM2.5 and 2015 Ozone Infrastructure SIPs and submitting in their place updated elements, as indicated in Appendix I of the Regional Haze SIP.

We certify that all portions of the Regional Haze SIP were properly noticed; evidence of public participation is included in Appendix D of the Regional Haze SIP. The Administrator of the NDEP has the authority to adopt and submit state implementation plans to USEPA, as indicated in Appendix J. The NDEP hereby adopts the Nevada Regional Haze State Implementation Plan for the Second Planning Period, along with the changes outlined in Appendix I of the Regional Haze SIP as revisions to the 2012 PM2.5 NAAQS and 2015 Ozone NAAQS Infrastructure SIPs for Nevada. We request the USEPA's approval of these submittals into the applicable Nevada SIP.
