A petroleum product release to the environment must be reported to the NDEP Spill Hotline by the end of the first working day after initial discovery in accordance with NAC 445A.347, if:

- 1) Petroleum is confirmed to have released to surface water or groundwater (regardless of quantity), or
- 2) The discovery of petroleum released to soil is greater than or equal to 3 cubic yards, or
- 3) A spill has occurred and the quantity of petroleum product spilled is greater than 25 gallons.

A suspected release of petroleum product to the environment must be reported to the NDEP Spill Hotline or Petroleum Fund staff by the end of the first working day after initial discovery in accordance with Board Policy Resolution 2017-01, if:

- 1) Petroleum product is observed to be leaking from the system during visual inspection of the tank or other aboveground components and product has saturated soil adjacent to the tank system, or
- 2) Annual testing of underground piping associated with an AST indicates a "Fail" result.
