Introduction

The Nevada Division of Environmental Protection (NDEP), Office of Financial Assistance (OFA), is pleased to submit to the Environmental Protection Agency (EPA) its Annual Report for Nevada's Clean Water State Revolving Fund (CWSRF) and Drinking Water State Revolving Fund (DWSRF) for the State Fiscal Year (SFY) 2022 (July 1, 2021 through June 30, 2022).

This 2022 Annual Report to EPA has been prepared in accordance with the Clean Water Act (CWA), Safe Drinking Water Act (SDWA), the Capitalization Grant requirements, the Operating Agreement between NDEP and EPA, and the Region 9 State Revolving Fund (SRF) annual Report Checklist. This report includes discussions of the status of Nevada's compliance with various statutory program requirements, program changes and progress made, information about loan recipients, and other pertinent financial information.

Executive Summary

Nevada has met its goals of funding Nevada-needed projects, conducting ongoing outreach and education for potential borrowers regarding the CWSRF and DWSRF programs, and taking steps to remain sustainable well into the future. The program's financial information has been audited as part of the State of Nevada Annual Comprehensive Financial Report (ACFR) and Single Audit Act. Results of the audit are shared in the CWSRF and DWSRF Financial Report.

Nevada does require projects to meet federal requirements as authorized by the equivalency guidance by EPA. However, all new loan commitments awarded within the fiscal year were executed after an environmental review was completed, applicable crosscutters were assessed, and the public had an opportunity to comment on the determination.

NDEP is monitoring all fiscal metrics of the programs to ensure we are meeting federal requirements in a timely manner. However, Nevada has a limited number of borrowers that can actually afford a loan. With the recent market risk and supply chain issues, borrowers have been less likely to take out a loan and have been deferring projects instead.

2022 CWSRF Goals

CWSRF Short Term Goals

- Provide financial assistance to recipients outlined on Nevada's 2022 Fundable List.
 - Some of the recipients outlined on the 2022 Fundable List were not ready to proceed and therefore, were by-passed. A reconciliation of this list is found in **Attachment A**.
- Ensure compliance with all pertinent federal, state, and local water pollution control laws and regulations.
 - Nevada met this goal through pre-bid meetings with borrowers, site visits, documentation of compliance, and audit reviews of draw requests.
- Ensure fiscal soundness and perpetuity in the CWSRF program, which provides below market rate financing for water pollution control projects.
 - Nevada is committed to ensuring fiscal soundness and perpetuity of the CWSRF program. Nevada has a limited number of borrowers that can afford a repayable loan and therefore, must remain competitive to the market. While working with our financial advisors, we lowered our interest rates, extended our loan terms, and provided additional loan incentives to borrowers to keep the CWSRF program competitive with the private market. Currently, borrowers are apprehensive about additional debt due to global market conditions and supply chain problems. We anticipate this to be a short-term slow down.
- Coordinate with other federal and state funding authorities to ensure systems receive as many resources as possible in funding their project.
 - NDEP is committed to frequent meetings with other partner funders through the Infrastructure in Nevada Communities (INC) committee. Coordination and communication with other funders continued on an as-needed basis to discuss projects and funding opportunities. Other funders within the State include the United States Department of Agriculture – Rural Development (USDA-RD), Community Development Block Grants (CDBG), and United States Indian Health Services (IHS).
- Market the CWSRF program to educate potential borrowers on funding green infrastructure projects, nonpoint source projects, and other emerging markets such as irrigation districts.
 - Nevada continues to educate communities about its ability to fund various types of projects.

CWSRF Long Term Goals

- Obtain optimum turnover of the CWSRF fund while maintaining the necessary reserve for debt service that safeguards the program's AAA rating from Standard and Poor's (S&P) Ratings.
 - The program continues to analyze its cash flows to ensure the fund is revolving as intended by Congress and maintains its outstanding AAA rating. Cash flow models analyze the program over a five-year period. Funds are committed as timely as possible based on borrower demand.
- Issue debt obligations as needed to provide funding to the program either to match the federal grants or provide additional resources for projects.
 - In SFY 2022, the program issued \$5 million in bonds to match its federal requirements. Debt is issued on an as-needed basis to not overextend the program.
- Enhance Nevada's systems that meet affordability requirements to ensure their longterm sustainability by working with systems to develop fiscal sustainability plans, reasonable rates to sustain their system, and capital asset reserves.

- CWSRF required fiscal sustainability plans to be incorporated for all projects since the enactment of the Water Resource Reform and Development Act of 2014. Nevada also requires borrowers receiving principal forgiveness funding to demonstrate they are being actively responsible with rate setting and placing funds into a capital asset reserve account to help them become self-sustaining. These requirements went into effect with the 2018 IUP and will become incorporated into all principal forgiveness loans moving forward.
- Ensure the program budget adequately supports resources, administrative activities, and anticipates future needs.
 - The Nevada Legislature must approve the operating and administrative budget for the CWSRF program. The SFY 2022-2023 biennium budget was prepared and submitted to the executive branch inclusion in the governor's recommended budget. The 2019 legislative session approved all requested funding. The SFY 2024-2025 biennium budget was submitted to the Governor's Finance Office in late August 2022. A separate budget reconciliation is prepared for EPA on a semi-annual basis.
- Develop a web-based application that will maintain accountability over the CWSRF program and allow electronic interfacing with borrowers.
 - The Nevada Infrastructure Financial System (NIFS) went live to staff in October 2021 and live to borrowers January 2022. The program has been successful in streamlining old paper-focused processes allowing staff and borrowers alike to access documents quickly, process draws timely, and accurately account for project processes. The system continues to be refined in a manner that increases efficiency and effectiveness in the programs, adapts to new federal funding and requirements, and increases user functionality.

DWSRF Short Term Goals

- Provide financial assistance to recipients outlined on Nevada's 2022 Fundable List.
 - Some of the recipients outlined on the 2022 Fundable List were not ready to proceed and therefore, were by-passed. A reconciliation of this list is found in **Attachment B**.
- Ensure compliance with all pertinent federal, state, and local laws and regulations.
 - Nevada met this goal through pre-bid meetings with borrowers, site visits, additional photos and documentation of compliance, and audit review of draw requests.
- Coordinate with other federal and state funding authorities to ensure systems receive as many resources as possible in funding their project.
 - NDEP is committed to frequent meetings with other partner funders through the INC committee. Coordination and communication with other funders continued on an asneeded basis to discuss projects and funding opportunities. Other funders within the State include USDA-RD, CDBG, and IHS.
- Market the DWSRF program to educate potential borrowers on funding opportunities with the program.
 - Nevada continues to educate communities about its ability to fund various types of projects. During the year, the SRF continued to contact potential borrowers about available resources, participated in conferences, and presented at webinars. Nevada has a limited number of borrowers that can afford a repayable loan and therefore, must remain competitive to the market. While working with our financial advisors, we lowered our interest rates, changed our regulations to extend our loan terms, and provided additional loan incentives to borrowers to keep the DWSRF program

competitive with the private market. Currently, borrowers are apprehensive about additional debt due to global market conditions and supply chain problems. We anticipate this to be a short-term slow down.

- Award subgrant agreements to organizations to provide technical assistance for capacity development in drinking water systems.
 - Two subgrant agreements were awarded to nonprofit organizations for a two-year period. The nonprofits selected demonstrated skill and proficiency in the awarded categories of work through a competitive process.
- Evaluate the risk to Nevada's Drinking Water to per- and polyfluoroalkyl substances (PFAS) contamination using the 2022 Nevada PFAS Action Plan.
 - In SFY22, a PFAS Action Plan was completed. In part, PFAS sampling and risk assessment tools were noted as areas for Nevada to pursue if funding allowed. A PFAS sampling contract is being pursued with sampling to occur in SFY23 and SFY24. A PFAS risk assessment tool contract is being investigated and may be issued in SFY23 or SFY24.
- Provide additional staff support to maximize the use of the multiple funding opportunities for small and disadvantaged communities, allowing Nevada to build PWS capacity.
 - In April 2022, the Interim Finance Committee of the state legislature authorized the addition of three new positions within OFA. One of those positions is tasked with coordination with and outreach to water systems for capacity development that ensures we are following our developed strategy.
 - A temporary employee is continuing to assist with the coordination efforts for capacity development.

DWSRF Long Term Goals

- Continue to assist Nevada's communities in fulfilling the requirements of the federal SDWA and State regulations through below AAA market rate financing for drinking water projects.
 - Nevada continues to contact systems across the State to work with them on their needs and ensure they are addressing their most critical needs first. Additionally, OFA's coordination meetings with the Bureau of Safe Drinking Water (BSDW) and the county health districts helps make sure OFA is understanding the needs in Nevada and targeting funding to systems in need.
- Obtain optimum turnover of the DWSRF fund while maintaining the necessary reserve for debt service that safeguards the program's AAA rating from S&P Ratings.
 - The program continues to analyze its cash flows to ensure the fund is revolving as intended by Congress and maintains its outstanding AAA rating. Cash flow models analyze the program over a five-year period. Funds are committed as timely as possible based on borrower demand.
- Issue debt obligations as needed to provide funding to the program either to match the federal grants or provide additional resources for projects.
 - In SFY 2022, the program issued \$5,000,000 in bonds to match its federal requirements. The program has not issued leverage bonds in its history but may if project needs require additional resources. Debt is issued on an as-needed basis to not overextend the program.
- Enhance long-term sustainability for Nevada's disadvantaged systems by working with systems to develop asset management plans, evaluating service goals, calculating sufficient rates to sustain systems, and funding capital reserve accounts.

- Nevada has begun requiring borrowers who receive principal forgiveness funding to prepare an asset management plan, demonstrate they are being actively responsible with rate setting, and placing funds into a capital asset reserve account to help them become self-sustaining. These requirements went into effect with the 2018 IUP and will become incorporated into all principal forgiveness loans moving forward.
- Ensure the program budget adequately supports resources, administrative activities, and anticipates future needs.
 - The Nevada Legislature must approve the operating and administrative budget for the CWSRF program. The SFY 2022-2023 biennium budget was prepared and submitted to the executive branch inclusion in the governor's recommended budget. The 2019 legislative session approved all requested funding. The system continues to be refined in a manner that increases efficiency and effectiveness in the programs, adapts to new federal funding and requirements, and increases user functionality.
- Coordinate with USEPA and Region 9 EPA to engage Nevada staff in an Area Wide Optimization Program (AWOP) to address long-term surface water, disinfection byproducts and groundwater treatment compliance.
 - Nevada staff participated in national and regional AWOP meetings. Discussions are ongoing with Region 9 EPA regarding potential next steps for local implementation. A total of \$130,000 has been requested in the 2022 DWSRF Bipartisan Infrastructure Law Supplemental grant that was applied for in late SFY 2023, to help with staff training from an EPA contractor.

Certification of Compliance

Operating Agreement

Nevada has complied with the conditions of the Operating Agreement. Nevada's Clean Water Operating Agreement was approved on September 29, 1989. The Drinking Water Operating Agreement was approved on April 27, 1998. NDEP combined the DWSRF and CWSRF into a single SRF Operating Agreement, which was submitted to EPA for approval in September 2018. This agreement also includes requirements in the Water Resources Reform and Development Act of 2014 (WRRDA). The September 2018 Operating Agreement remains pending EPA approval at the end of SFY 2021.

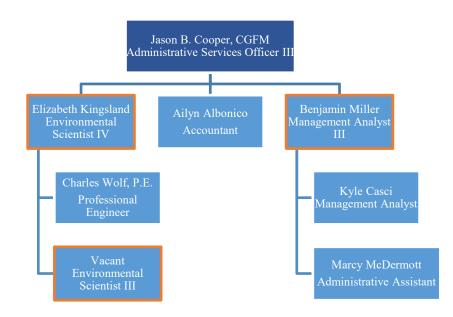

Administration Requirements

Staffing Levels at the end of the year



In April 2022, the Interim Finance Committee of the state legislature authorized the addition of three new positions within OFA (highlighted above in orange). NDEP now has eight full-time staff that administer the DWSRF, CWSRF, and the State Capital Improvements Grant Program. Programmatic demands within SFY 2022 and additional federal funding provided justification to State budgetary authorities for the addition of these three permanent staff. The NIFS is also helping to streamlining processes. For SFY 2022, both the DWSRF and CWSRF complied with program requirements in a timely manner and responded to potential and current loan applicants as timely as possible.

Congressional and Public Inquiries

NDEP received a request from Representative Steven Horsford (NV 4th District) in June 2022 for a list of projects funded through the SRF programs within his district. OFA prepared a detailed map and list and supplied that to his office.

No public records requests were responded to within SFY 2022.

Loan Terms and Conditions

Disadvantaged Business Enterprise (DBE) Certifications

A fair share objective is a goal based on the capacity and availability of qualified, certified Minority Business Enterprise (MBE) and Women Business Enterprise (WBE) in the relevant geographic market for the grant recipient. A fair share objective is not a quota. A recipient cannot be penalized for not meeting its fair share objectives. Once negotiated, fair share objectives remain in place for three years. The most recent negotiated fair share objectives were approved in October 2016.

The EPA Disadvantaged Business Enterprise guidance information and "fair share" goals are included in all sub-recipient construction bid documents. MBE/WBE reports were prepared for the annual period ending Federal FY2020 (October-September).

Lobbying Activities

The certificate regarding lobbying activities is required to be acknowledged and signed by all borrowers as part of the funding agreement. The program ensured all borrowers followed this requirement.

Federal Debarment and Suspension

The program requires in all loan contracts the primary recipient and anyone performing work on the project to be registered with <u>www.sam.gov</u>. Unique Entity Identifier's and DUNS numbers are collected and verified in the federal system.

Programmatic Audits and Prior Year Requests

The SFY 2021 Annual Programmatic Review by EPA was finalized in SFY 2023. The review noted the following items:

- 1. Operating Agreement
 - a. NDEP will continue to work with EPA Region 9 to complete an update to the operating agreement.
- 2. Drinking water fund utilization rate
 - a. NDEP has continued to monitor all financial metrics closely to ensure proper utilization of funds.
- 3. Drinking water cash and equivalents from financial statements
 - a. NDEP has continued to monitor all financial cash balances closely to ensure proper disbursement of funds.
- 4. Drinking water Total net ratio
 - a. NDEP has continued to monitor the growth of the program.
- 5. Clean water fund utilization rate
 - a. NDEP has continued to monitor all financial metrics closely to ensure proper utilization of funds.
- 6. Clean water retained earnings rate
 - a. NDEP has continued to monitor the growth of the program.
- 7. Clean water partnership with EPA to identify opportunities to increase demand for CWSRF.
 - a. NDEP will continue to work with EPA to increase demand in the CWSRF program.
- 8. Clean Water total net
 - a. NDEP is committed to making sure the CWSRF program fund continues to grow.
- 9. Clean water net interest margin
 - a. NDEP is committed to making sure the CWSRF program fund continues to grow. It was noted in the SFY 2020 report that Nevada demonstrates solid growth driven by interest earnings.

Reporting Requirements

CBR/PBR Reporting

Financial and program information for all projects is entered into CW Benefits Reporting (CBR) and the DW Project and Benefits Reporting (PBR) at the time of commitment. They are updated periodically as changes occur.

FFATA Reporting

Federal Funding Accountability and Transparency Act (FFATA) information is entered upon approval of the projects and upon contract award.

Intended Use Plan

Both the CWSRF and DWSRF IUPs are prepared each year prior to requesting funding from the federal government. They outline how Nevada will utilize the funds and manage the program. The

2022 reports are posted on the program's website and available for public comment prior to final adoption.

Technical Compliance

Environmental Review

The environmental review process is codified within the Nevada Administrative Code (NAC). It has been reviewed by EPA, applies to all projects funded by the CWSRF or DWSRF programs, and generally follows the provisions of the National Environmental Policy Act. The final loan contract is executed only after NDEP has conducted an environmental review, a determination is made, and has provided the public 30 days to comment on the determination.

Crosscutters

The loan contract requires that loan recipients comply with applicable federal cross-cutting authorities. The State is required to comply with applicable federal cross-cutting authorities by the assistance and operating agreements it signs with EPA and by applicable federal regulations.

Davis-Bacon Requirements

NDEP has included a condition requiring compliance with Davis Bacon Wage Rates in all loan agreements executed on or after October 30, 2009. Compliance with the standards is monitored by staff through draw request questions, site inspections, and independent audit analysis.

American Iron and Steel

NDEP has included a condition requiring compliance with American Iron and Steel in all loan agreements executed after June 9, 2014, unless the State approved the engineering plans and specifications for the project prior to the June 9, 2014 date. Compliance with the standards is monitored by staff through draw request questions, submission of certifications, site inspections, and independent audit analysis.

Site Visits and Monitoring

NDEP performs construction site inspections as required in the loan agreement and in accordance with the NAC. In most cases, projects receive at least one site inspection. For long-term projects (construction expected to take more than a 12-month period to complete), at least one site visit ordinarily occurs within each 12-month period. In addition, the borrower is expected to provide periodic construction updates. These may be daily, weekly, or monthly and are normally accompanied by project photos. Most updates are now received electronically.

A final site visit is initiated by receipt of a notice of substantial completion. This site visit normally occurs prior to the final loan disbursement.

Financial Compliance

Annual Financial and Single Audits

The program's assets, liabilities, and operating activities are audited annually, as they are included in Nevada's Comprehensive ACFR (<u>http://controller.nv.gov</u>) as part of the Water Projects Loan Fund – a major enterprise fund.

The program compiles this audited data into a separate financial report intended for EPA's analysis and review (https://ndep.nv.gov/water/financing-infrastructure/state-revolving-fundloans/drinking-water). The program cannot prepare a comprehensive financial report separately from the State ACFR as various assets, liabilities, and operations that affect the program are valued, accrued, and audited by other agencies within the State. Specific assets and liabilities include, but are not limited to, investment fair values and accruals, compensated absences, pension liabilities, group insurance, and arbitrage liabilities. While finances are a major concern to the EPA program staff, they agreed that having the CWSRF and DWSRF audited separately is not an efficient or effective use of State funds. EPA has allowed NDEP to provide a reconciliation of the most recently audited ACFR and the related unaudited financial statements compiled by the program, as stated in the SRF Operating Agreement.

The State of Nevada is audited every year as a single entity for purposes of the single audit. The CWSRF and DWSRF are included in that audit and are broken out into separate components. The Independent Accounting Firm chosen by the legislature reviews each program's risk and materiality. Further analysis is completed based upon standards applicable to financial audits contained in Government Auditing Standards – issued by the Comptroller General of the United States. The single audit for SFY 2021 will not be available for review until spring 2022. Prior single audits can be viewed by visiting the Nevada Legislative Counsel Bureau Audit Divisions website at: http://leg.state.nv.us/Division/Audit/.

Fundable List Reconciliation

Several projects on both the CWSRF and DWSRF 2021 Intended Use Plans were not ready to proceed by the end of the year. **Attachment A** contains project activities for the CWSRF program during the fiscal year. **Attachment B** contains a list of project activities for the DWSRF program during the fiscal year. Both programs have the State authority to bypass any project on the priority list not ready to proceed. During 2022, several projects were bypassed to fund other projects that were ready to proceed. A 30-day notice is provided to all those on the list above the project ready to proceed, giving them time to appeal the program's decision, unless an emergency project is presented and approved to the Board for Financing Water Projects. No petitions to these bypass notices were received.

Timely Use of Funds

Nevada ordinarily applies for and receives its capitalization grants within one year of the appropriation date. NDEP makes every effort to receive all payments in time. NDEP draws federal grant monies after receipt of an approved reimbursement request from borrowers. NDEP also

requires borrowers to submit estimated loan draw schedules with their applications. Nevada monitors the loans and contacts systems when disbursement requests do not appear to be timely.

NDEP evaluates DWSRF systems using criteria outlined in the Intended Use Plan. A system needs to obtain 50 or more points to be eligible for a principal forgiveness loan. Criteria includes the community's MHI, population trends, loan affordability, green project status, enforcement actions levied, and other factors. Because some projects on the fundable list are not ready to proceed, the projects that actually received a grant for the subsidy requirements have changed. See **Attachment B** for DWSRF projects receiving subsidy within SFY 2022. NDEP will ensure that at least six percent of the federal subsidy requirement to disadvantaged communities is met.

Sustainability

The programs continue to analyze its cash flows to ensure the funds are revolving and sustainable to adequately assist Nevada's systems when the need arises. Cash in the funds are committed utilizing a cash flow analysis over a five-year period. Current cash in the accounts are adjusted by anticipated receipts and disbursements over a five-year period to determine a lowest balance level in the fund. The programs further maintain a minimum of \$20 million in each program fund to ensure enough cash is available to cover unanticipated draws or emergencies for projects. Any remaining cash in each fund is then utilized to determine the size of loan that can be committed. Borrowers are required to provide a quarterly cash draw forecast so the programs cash flow analysis can be as accurate as possible.
