NOTICE OF PROPOSED ACTION

The Administrator, Division of Environmental Protection, Carson City, Nevada is issuing the following notice of proposed action under the authority of the Nevada Revised Statutes, the Nevada Administrative Code, and the Safe Drinking Water Act. The Administrator is proposing to re-issue General Permits GU07RL and GU07RS.

Two Underground Injection Control (UIC) General Permits for groundwater remediation have been drafted for public comments. These permits authorize injection activities associated with remediation facilities for both long term projects (GU07RL; more than six months) and short term projects (GU07RS; less than six months). Both general permits authorize two (2) injection discharge categories under one general permit. These permits will allow the Nevada Division of Environmental Protection to provide timely coverage for discharges which when properly managed will not adversely impact public health, water quality or the environment. Permit requirements have been established for the following two discharge categories: Discharge Category 1 - chemical compounds, bioremediation agents, and nutrient injections for in-situ groundwater treatment; and Discharge Category 2 - Water that has been extracted, treated, and reinjected to meet groundwater quality criteria. Monitoring and reporting requirements have been established for these categories based on the type of discharge.

On the basis of preliminary review of the requirements of the Nevada Revised Statutes, the Nevada Administrative Code, the Safe Drinking Water Act, and implementing regulations, the Administrator proposes to renew general permits GU07RL and GU07RS, with modifications, for a five (5) year period, subject to certain discharge limitations and special conditions.

People wishing to comment upon or object to the proposed determinations by the Administrator regarding permit issuance should submit their comments or requests, in writing, hand delivered or postmarked no later than 5:00 P.M. on 11/10/2025, either in person or by mail to:

The request must be filed within the comment period and must indicate the interest of the person filing the request and the reasons why a hearing is warranted. All comments or objections received within the thirty (30) day period will be considered in the formulation of final determination(s) regarding the application.

If written comments indicate a significant degree of public interest in the proposed permit, the Administrator shall hold a public hearing. Public notice of such a hearing will be issued not less than thirty (30) days prior to the hearing date.

If no hearing is held and the determinations of the Administrator are substantially changed from the tentative determinations, the Administrator will give public notice of the revised determinations. Additional comments and objections will be considered at that time.

A public hearing on the proposed determination can be requested by the applicant, any affected State, any affected interstate agency, the Regional Administrator of EPA Region IX or any interested agency, person or group of people. The request must be filed within the comment period and must indicate the interest of the person filing the request and the reasons why a hearing is warranted. Any public hearing determined by the Administrator to be held must be conducted in the geographical area of the proposed discharge or any other area the Administrator determined to be appropriate. All public hearings must be conducted in accordance with NAC 445A.238.
