



NOTICE OF PROPOSED ACTION

The Administrator, Division of Environmental Protection, Carson City, Nevada is issuing the following notice of proposed action under the Nevada Revised Statutes and/or the Clean Water Act, where applicable. The Administrator has received an application for a Groundwater Discharge, permit number NS0020009 from the following applicant:

Permit NS0020009, HAWTHORNE UTILITIES:

The Permittee, Hawthorne Utilities, has applied for the renewal of Permit NS0020009 for the Hawthorne Utilities Wastewater Treatment Plant (HUWWTP), at the Hawthorne Army Depot, 1 South Maine Avenue, outside of the town of Hawthorne, within Mineral County, Nevada. The Permittee proposes to continue discharging treated wastewater to groundwater of the State via three rapid infiltration basins (RIBs). The HUWWTP is located 2.5 miles northwest of the town of Hawthorne. The HUWWTP can treat an average daily maximum flow rate of 0.50 million gallons per day (Mgal/d). The HUWWTP is made up of the following plant unit processes - headworks including a grit chamber, a primary treatment pond (Pond 1), two secondary treatment ponds (Ponds 2 and 3), wetland cells, RIBs, and three (3) monitoring wells being both upgradient (MW-1) and down-gradient (MW-2 and MW-3). With adherence to permit term requirements, and under normal operating and maintenance conditions, no degradation of the groundwater of the State is anticipated.

On the basis of preliminary review of the requirements of the Nevada Revised Statutes, as amended, and implementing regulations, the Administrator proposes to issue Permit NS0020009 to discharge for a five (5) year period, subject to certain effluent limitations.

Persons wishing to comment upon or object to the proposed determinations by the Administrator regarding permit issuance should submit their comments or request, in writing, hand delivered or postmarked no later than 5:00 P.M. on 12/08/2025, either in person or by mail to:

The request must be filed within the comment period and must indicate the interest of the person filing the request and the reasons why a hearing is warranted. All comments or objections received within the thirty (30) day period will be considered in the formulation of final determination(s) regarding the application. If written comments indicate a significant degree of public interest in the proposed permit, the Administrator shall hold a public hearing. A public notice of such hearing will be issued not less than thirty (30) days prior to the hearing date.

If no hearing is held and the determinations of the Administrator are substantially changed from the tentative determinations, the Administrator will give public notice of the revised determinations. Additional comments and objections will be considered at that time.

A public hearing on the proposed determination can be requested by the applicant, any affected State, any affected interstate agency, the Regional Administrator of EPA Region IX or any interested agency, person or group of persons. The request must be filed within the comment period and must indicate the interest of the person filing the request and the reasons why a hearing is warranted. Any

public hearing determined by the Administrator to be held must be conducted in the geographical area of the proposed discharge or any other area the Administrator determined to be appropriate. All public hearings must be conducted in accordance with NAC 445A.238.
