## NOTICE OF PROPOSED ACTION

The Administrator, Division of Environmental Protection, Carson City, Nevada is issuing the following notice of proposed action under the Nevada Revised Statutes and/or the Clean Water Act, where applicable. The Administrator has received an application for a Groundwater Discharge, permit number NS2025519 from the following applicant:

TL TALUS LLC 10345 PROFESSIONAL CIRCLE, SUITE 200 RENO, NV - 89521

## Permit NS2025519, TALUS VALLEY DEVELOPMENT:

The Permittee, TL Talus LLC, has applied for a new groundwater discharge permit NS2025519 for the Talus Valley Development project, located at 3300 Bella Vista Ranch Road, in Reno, within Washoe County, Nevada. The Talus Valley Development project is comprised of approximately 772 acres of land located in southeast Reno, west of Veteran's Parkway, between Mira Loma Road and South Meadows Parkway on which a master planned, multi-community (three) housing development, with intermixed retail areas, is to be constructed. The Permittee has applied to utilize reclaimed water for dust control and construction activities within the boundary of the project, in areas of disturbance and on stockpiles. The reclaimed water will be delivered from the South Truckee Meadows Water Reclamation Facility (STMWRF permit NS0040024).

Reclaimed water will be pumped from the STMWRF, via a pipeline system, and into onsite holding tanks. Water will then be pumped into water trucks for construction activities and dust suppression purposes. Water will be applied consistently with standard dust control practices, such that pooling and/or ponding are minimal, and no runoff from the site occurs. All reuse activities will be conducted in accordance with a Division approved Reclaimed Water Management Plan (RWMP) required within 90 days from the date of permit issuance.

On the basis of preliminary review of the requirements of the Nevada Revised Statutes, as amended, and implementing regulations, the Administrator proposes to issue Permit NS2025519 to discharge for a five (5) year period, subject to certain effluent limitations.

Persons wishing to comment upon or object to the proposed determinations by the Administrator regarding permit issuance should submit their comments or request, in writing, hand delivered or postmarked no later than 5:00 P.M. on 08/04/2025, either in person or by mail to:

The request must be filed within the comment period and must indicate the interest of the person filing the request and the reasons why a hearing is warranted. All comments or objections received within the thirty (30) day period will be considered in the formulation of final determination(s) regarding the application. If written comments indicate a significant degree of public interest in the proposed permit, the Administrator shall hold a public hearing. A public notice of such hearing will be issued not less than thirty (30) days prior to the hearing date.

If no hearing is held and the determinations of the Administrator are substantially changed from the tentative determinations, the Administrator will give public notice of the revised determinations. Additional comments and objections will be considered at that time.

A public hearing on the proposed determination can be requested by the applicant, any affected State, any affected interstate agency, the Regional Administrator of EPA Region IX or any interested agency, person or group of persons. The request must be filed within the comment period and must indicate the interest of the person filing the request and the reasons why a hearing is warranted. Any public hearing determined by the Administrator to be held must be conducted in the geographical area of the proposed discharge or any other area the Administrator determined to be appropriate. All public hearings must be conducted in accordance with NAC 445A.238.
