

NOTICE OF PROPOSED ACTION

The Administrator of the Division of Environmental Protection (NDEP), Department of Conservation and Natural Resources, Carson City, Nevada, is issuing the following Notice of Proposed Action under the authority of the Nevada Revised Statutes, the Nevada Administrative Code (NAC), and the federal Safe Drinking Water Act.
