PUBLIC HEARING

Pursuant to Nevada Revised Statutes (NRS) Chapter 445B, the Nevada Administrative Code (NAC) Chapter 445B, and the Clean Air Act, the Division of Environmental Protection is issuing the following Notice of Proposed Action.

The Director received an application for a new Class II Air Quality Operating Permit, AP4789-4701 (FIN A2591) from the following applicant:

Iron Horse Nevada, LLC 7100 Airport Road Winnemucca, NV 89445

Iron Horse Nevada, LLC Transload Facility is accessed by taking exit 173 to NV-289/W. Winnemucca Blvd, turning left, then turning right onto W. Rose Creek Rd and traveling 1.4 miles. Turn left onto Airport Rd and, in less than one mile, turn right onto the facility access road. The project is located in all or portions of Sections 16 and 17, Township 35N, Range 37E, M.D.B.&M.

The facility will include various systems to transfer materials from railcars to over-the-road tanker trucks or (in some cases) transfer from trucks to railcars. An NDEP air permit is required due to the equipment to be constructed at this facility for "transloading". In addition, critical equipment will be powered by an emergency generator in the event of power loss, also requiring air permitting action.

On the basis of the preliminary review and the requirements of the NRS, the NAC and the Clean Air Act, the Director is hereby announcing his intent to issue the proposed Class II Air Quality Operating Permit based on a review of the information submitted.

Pursuant to NAC 445B.3395.9(f), the Director is providing this notice of a Public Hearing on the proposed action. The Public Hearing will be held on **December 3, 2025** in Winnemucca, Nevada at 5:00 p.m. at the following location:
